He was unanimously elected and signed his declaration of acceptance of office which was witnessed by the Clerk. 23/24/117 **DECLARATIONS OF INTEREST** - none declared. 23/24/118 MINUTES OF PREVIOUS MEETING - were confirmed and signed. UPDATES ARISING FROM PREVIOUS MEETINGS AND NOT LISTED - there had been 23/24/119 some movement regarding bringing fibre broadband to the village and this would be put on the next agenda. 23/24/120 PILLAR BARN IF MARK LIDSTER ATTENDS - In spite of several emails inviting him to attend no response has been received. A member of the public made some observations and following discussion it was agreed that they should write privately and also that SCllr Munt would chase up Mr Lidster. The member of the public advised councillors to look at the BNG (Biodiversity Net Gain) principles. 23/24/ 121 **SOMERSET COUNCILLORS' REPORTS** - SCllr Munt reported that last month Somerset Recycling had achieved 100% of plastic recycled. Other green initiatives are also taking place. Gritters are ready for operation when required. The firm which had previously held the contract for highway maintenance had not had its contract renewed and a new firm had been granted the contract as from April 2024. There is a serious financial situation in Somerset Council largely as a result of the doubling of costs of adult social care. A letter regarding asset and service devolution was discussed but it was noted that for a small council there is not much more that Edington can do. Somerset's shortfall is in the region of £140m per annum. 23/24/ 122 LOCAL COMMUNITY NETWORKS - With regard to the Asset and Services Devolution letter it was noted that this will be discussed at all of the next LCN meetings. 23/24/ 123 COMMEMORATIVE BENCH - BRIAN TILBURY - Cllr Gilbert would look further into the choices as there is such a large range. It was felt that recycled plastic, which would be environmentally friendly might be a good choice. Gwilliams charity Make a difference could be approached for a donation towards this. **HIGHWAYS** 23/24/124 Any updates a. SID poles, Broadway signage, Broadmead Lane unsuitable for HGVs and outstanding issues responses to all these had been received. The SID poles would be replaced shortly and because of the problems we would not be charged. Unsuitable for HGVs signs will be erected at each end of Broadmead Lane. The original proposals for improvements to safety along Broadway had not included anything covering the length between the two sections of the village. The Clerk had complained and some no footway signs would be erected at each end with slow written on the road. The Clerk to mention to Highways that stating that there is no footway for 400 yards is misleading as there are no footways in Edington. ii. Pothole outside Holywell House - This has deteriorated. The Clerk had taken photos which had been sent to SCllr Martin.

iii. Burtle signpost at junction of chandlers Lane and Holywell Road - no update.

- c. <u>Holywell Road/Chandlers Lane water problems</u> Cllr Gilbert updated the meeting. She had put blue dye in as required and it failed to show at the problem area. Following testing the water Wessex Water confirmed that it is not sewage. Wessex Water will be adding dye to the manhole and carrying out further camera investigations. An application has been made by the authorities for Highways to put in a soakaway. The Clerk would also request this.
