- 23/24/ 180 **PRESENT** - Cllrs Charlesworth (in the Chair), Heale, Welch and Vine.
- 23/24/ 181 **APOLOGIES FOR ABSENCE** - Received and approved from Cllr Gowing.
- 23/24/ 182 **ALSO PRESENT** - 0 members of the public.
- 23/24/ 183 **IN ATTENDANCE** - The Clerk to the Council.
- 23/24/ 184 **DECLARATIONS OF INTEREST** - Cllr Vine declared an interest in Affordable Rural Housing as he might benefit from the scheme's activities.
- 23/24/ 185 **MINUTES OF PREVIOUS MEETING** - confirmed and signed.
- 23/24/ 186 **UPDATES ARISING FROM PREVIOUS MEETINGS AND NOT LISTED** - none.
- 23/24/ 187 **SOMERSET COUNCILLORS' REPORTS** - Neither Somerset Councillor was present.
- 23/24/ 188 **LCNs** - (Including EHM) - although some ideas of costs involved in using the EHM scheme it was still far from clear what actions Somerset Highways would be undertaking. The only meeting held had been in Shapwick and run by a Kier representative with nobody from Highways present.
- 23/24/ 189 **PRESENT** - Cllr Vine left the meeting.
- 23/24/ 190 **AFFORDABLE RURAL HOUSING** - It was agreed that although it would be wonderful to have affordable housing in the village there is nowhere for it to go. Also, the existing infrastructure is already incredibly overloaded and unable to cope and adding anything more would only exacerbate the problems.
- 23/24/ 191 **PRESENT** - Cllr Vine returned to the room.
- 23/24/ 192 **DEVOLUTION** - It was felt that the village would not benefit from this proposal and it was likely to increase costs.
- 23/24/ 193 **BTMG (BRIAN TILBURY MEMORIAL GROUND ON THE NIDON)** - Some trees have been blown down on the West plot. At least three medium sized saplings and one big tree (thought to be Ash) are lying on the ground. The Clerk will contact somebody for advice as to what action to take to best benefit the ecology.
- 23/24/ 194 **HIGHWAYS & FLOODING**
- a. Speed Indicator Device (SID) - The Clerk no longer driving meant she doesn't meet Mr Mockridge any more. Cllr Charlesworth would contact him direct. It is understood that she should be able to log on to the device with her smart phone. Once she has achieved that then the device can be moved to its other position. She would keep everyone informed.
 - b. Flooding - the meeting held in the Village Hall had been well attended and the speaker from the River Authority had proved really informative and interesting to the audience. Cllr Charlesworth thanked all who had attended. Now it was agreed that more jetting is crucial and it was agreed that Cllr Charlesworth should contact Mr Gill directly to try and arrange an on site visit with councillors and to discuss various problems. Kier should let us know when they plan to come to the village to undertake work and it was agreed that this work should be monitored and recorded. Cllr Vine would talk to a local farmer regarding ditching/drainage concerns. Cllr Charlesworth would speak to the Village Hall manager about sustainable drainage. There are serious concerns regarding flooding for the short, the mid and the long term. A specific area was mentioned as a trouble spot and Cllrs Charlesworth and Heale would meet to look at it.
 - c. Jetting and any problems still existing - included in the above.
 - d. Nidon Lane - no update.
 - e. Enhanced Highway Maintenance (EHM) - covered under LCNs.
 - f. Problems arising and any other highway matters - A pothole near Byways by the junction of Church Road and Holywell Road needs to be reported.
